

# Call for Abstract Submissions

## **2015 GovMaker Conference**

**Delta Fredericton, New Brunswick - November 23 and 24, 2015**

**Abstract Deadline: August 28, 2015**

U.S. President Barack Obama famously stated in his Open Government Directive: “The challenges we face today — from saving our planet to ending poverty — are simply too big for government to solve alone. We need all hands on deck.”

If you had the power to design New Brunswick’s healthcare system, education system, elder care system, or food system, what would it look like? What could government do to facilitate that change? Non-governmental organizations? Post-secondary institutions? The private sector? The GovMaker conference on Nov. 23-24 is seeking to transform citizens’ relationship with government in New Brunswick.

At the frontiers of 21st Century citizenship and governance, we are seeking stories and experiments that demonstrate how the citizen-government relationship can be different. We seek abstracts for presentations on projects that have contributed to (or show promise of) transforming our institutions by small steps or quantum leaps.

There is a growing movement to open government; to advance citizen engagement and create a more collaborative democracy, while making data open to drive evidence-based decision making and public service enhancements.

An open government strives for transparency, encourages civic participation, and promotes collaboration. The late Hon. Andy Scott had this same vision when he founded the NB Social Policy Research Network (NBSPRN). Structured on the value of networked governance, NBSPRN takes a horizontal approach to policy making by bringing together citizens from across sectors: community organizations, civil servants, policy makers, business leaders, and academics. These types of cross-sectoral networks represent the combinations we need to increase citizen participation and create a more open form of government; one that develops solutions with society, not for society.

The second annual GovMaker Conference will offer concurrent sessions within two streams: 21<sup>st</sup> century citizenship and 21<sup>st</sup> century governance. We would like to extend an invitation to participate in this exciting event!

Three types of contributions are suggested:

1. Panel Discussion
2. Lightning Talk Presentation (presentation of 5-7 minutes)
3. Workshop
4. Poster

We welcome abstract submissions (maximum 250 words) outlining your proposed panel; presentation, workshop or poster. Please indicate your selection in the title of your abstract.

Proponents of accepted abstracts will be invited to present during the conference. Those proposing a panel will be asked to indicate a theme and propose a title for the panel. Those proposing a presentation will be invited to give a lightning talk (5-7 minutes). Proponents of accepted workshops will be asked to prepare a more detailed outline for the workshop. Proponents of accepted posters will be asked to prepare their full poster for the Conference.

All presentations, panels and workshops will be filmed and included online on the GovMaker Conference website. All presenters must register for the conference, costs are not covered (registration and payment can be made after acceptance notification has been received).

Notifications will be ongoing during the review process – however, an agenda will not be decided until after the final deadline for submissions.
